The Hopkinton Fire Department is currently surplusing a **2002 E-One Pumper Cyclone with a 6 person cab**. This truck has a **Detroit Diesel L6 60 Series engine and features a 5-speed automatic transmission** with automatic controls. It has a **2,000 GPM Hale pump, a 1,200-gallon water tank, and a 15-gallon Class A and 50-gallon B foam system**. Additionally, it is equipped with a **10,000-watt Watt Generator and a 200-foot cord reel**. The truck is constructed with an aluminum cab and a stainless steel body and was recently taken out of service due to the department acquiring a new pumper.

The engine and generator start and run and drive, and the pump operates effectively. The truck was last inspected in 2023, and the pump was last certified in October 2023. The Engine has 4,088.3 hours and 48,479 miles, and the generator has 321 hours.

There are no fire hoses included with the sale of this vehicle.

The truck has some minor cosmetic defects and bubbling in the paint. The tank has a small crack in its top seam.

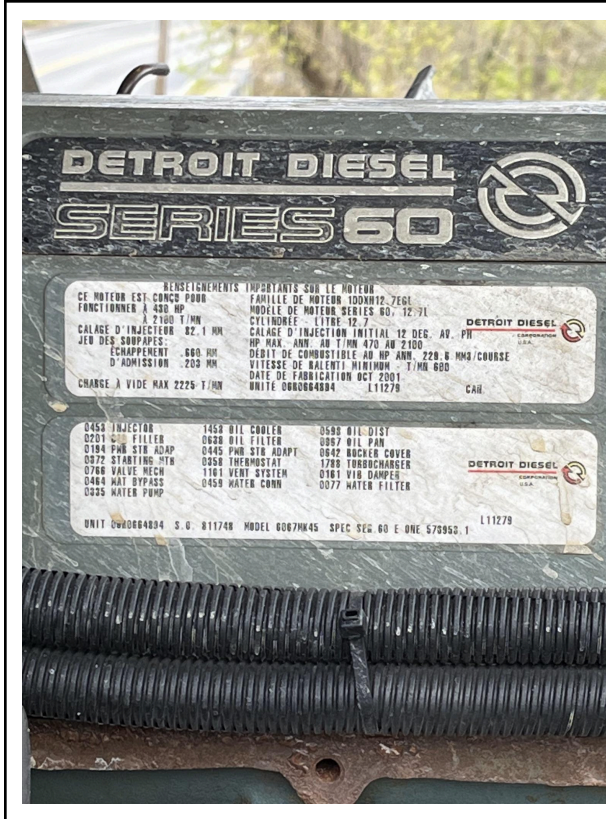

2. CONDITIONAL BIDS WILL NOT BE ACCEPTED.

3. PAYMENT IS TO BE MADE BY **CERTIFIED CHECK** PAYABLE TO THE TOWN OF HOPKINTON, AND PRESENTED TO THE FIRE DEPARTMENT AT TIME OF PICK UP OR BEFORE.

4. THE *BUYER* SHALL PICK UP THE VEHICLE WITHIN SEVEN (7) DAYS (Friday, Saturday, Sunday and Holidays excluded) OF THE NOTIFICATION BY THE *OWNER* THAT THE EQUIPMENT IS READY FOR PICK UP. THE *BUYER* WILL BE REQUIRED TO COORDINATE THE REMOVAL OF THE MATERIAL WITH THE FIRE DEPARTMENT. THE PICK UP SHALL BE MADE DURING NORMAL BUSINESS HOURS, 9 a.m. to 4 p.m., MONDAY THROUGH THURSDAY, IN THE PRESENCE OF AN AUTHORIZED EMPLOYEE OF THE FIRE DEPARTMENT. THE COST OF PICK UP AND TRANSPORTATION SHALL BE THE SOLE RESPONSIBILITY OF THE *BUYER*.
