Had thermocouple for oven partially removed before I realized I do not have the correct thermocouple and that one will need to be ordered. Put old one back in. Verified pilot safety closed and left note for oven. Changed out all pilots as they shared the same stem and flames were uneven unless new pilots were installed. Checked for gas leaks, none found. No issues reported with griddle and right oven.

 Removed front panels of range to access old thermocouple to remove. Replaced with new. Took awhile to re-assemble oven and verify no leaks. No gas leaks upon departure. Ran oven to 350 degrees. Oven cycled off and cycled back on within 15 degrees of setpoint. Ok for use.
