

All Buyers of auctioned items from the Morris County Municipal Utilities Authority (MCMUA) must sign the attached **Indemnity for Purchase** form on page 3 below. Additionally, insurance must be provided as explained below. Please submit all insurance documentation to Insurance@mcmua.com. **Please be advised equipment is not permitted to be picked up until all insurance is approved and funds received.**

Insurance Requirements for Buyers of Auctioned Items

- **Vehicles Able to be Driven off the MCMUA Site**
 Prior to arranging the date for removal, any business or individual purchasing a vehicle which will be driven off the MCMUA site, the Buyer must provide proof of Auto Liability (as detailed in the table below), for approval by the County Risk Manager.
- **Vehicles to be Towed off the MCMUA Site**
 Prior to arranging the date for removal, any business or individual purchasing a vehicle which will be towed off the MCMUA site, the Buyer must provide proof of the tow company’s insurance (as detailed in the table below) and tow license, for approval by the County Risk Manager.
- **Removal of Any Other Items Needing Equipment for Removal (including a roll-off truck)**
 Prior to arranging the date for removal, any Buyer which needs to remove any items that need equipment for removal, the Buyer must provide a certificate of insurance (as detailed in the table below) and endorsement form (sample provided on page 2) for approval by the County Risk Manager.
