The Erie Regional Airport Authority makes no warranty, guaranty or representation of any kind, expressed or implied, as to the merchantability, quantity, kind, character, quality, weight, size, or description of any of the property or its fitness for any use or purpose. Most items for sale are used and may contain defects not immediately detectable.

When permitted the bidder is invited, urged and cautioned to inspect the property to be sold prior to submitting a bid. Property/listings with viewing options will be available for inspection, date(s), time(s) and location(s) will be specified in the listing. In no case will failure to inspect constitute grounds for the withdrawal of a bid.

Persons attending during exhibition, inspection, sale or removal of goods assume all risks of injury, damage or loss to person and/or property and specifically release the Erie Regional Airport Authority and Municibid from liability there from.

The Erie Regional Airport Authority reserves the right to reject any and all bids and to withdraw from sale any of the items listed.

Payment in full is due not later than 5 working days from the date of the Notice of Award. Payment shall be in the form of Cashier's Check, Certified Check or U.S. Postal Money Order ONLY. Also included with payment should be the notice of award. Please note, it may take 3 to 5 days to process your payment once it is received.

All items must be removed within 10 working days from the date of issuance of the Salvage Removal Order. The Salvage Removal Order will be received via email, to the e-mail address provided by user during registration with Municibid and will include a contact name and number to call to make an appointment to remove your purchased item(s) Successful bidders are responsible for loading and removal of any and all property awarded to them from the location designated in the Salvage Removal Order. The purchaser will make all arrangements and perform all work necessary, including packing, loading and transportation of the property. Under no circumstances will the Erie Regional Airport Authority assume responsibility for packing, loading or shipping. Property must be removed by appointment only, excluding legal holidays, as directed in the Salvage Removal Order. All sales are final upon removal. Units remaining on site will be subject to a \$25.00 per unit per day storage fee. No exceptions. Strictly enforced.

Titles. Upon receiving notice and processing of payment buyers will have the titles transferred at a local notary service of the sellers' choice.

Default shall include (1) failure to observe these terms and conditions; (2) failure to make good and timely payment; or (3) failure to remove all items within the specified time. Default may result in termination of the award and suspension from participation in all future sales. If the purchaser fails in the performance of their obligations, the Erie Regional Airport Authority may exercise such rights and

may pursue such remedies as are provided by law. The Erie Regional Airport Authority reserves the right to place any default item back into auction without any reimbursement to the successful bidder.
